## FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

#### President: 1.

He/ She presides over all the members of the General Body and Executive Committee. He can cast his vote in the case of a tie in decision making. He can supervise all branches of the society.

## Vice - President:

He/She shall assist the President in discharging his functions. In the absence of the Chairman he will perform the duty of the Chairman as entrusted by the Chairman.

#### Secretary: 3.

He/ She is the Chief Executive Officer of the Society and Custodian of all records relating to the society and correspondent on behalf of the Society. He has to take on record all minutes of the Society. Would convene both the Executive Committee and General Body of the society with the permission of the Chairman. He guides the Treasurer in preparing the budget and expenditure statement to place before the General Body for its approval.

Secretary is exclusively authorised to open and operate Bank Accounts and to borrow funds from Banks & Financial Institutions and to execute all necessary documents to obtain such loans on behalf of the society.

Secretary is further authorise to enter into any agreements on behalf of the Society with Govt., Universities, Local bodies, Companies, Firms and Individuals.

### Treasurer:

He/She is responsible for all financial transactions and Funds of the society. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the society jointly with the Secretary or Chairman.

### Quorum:

1/3 (One Third) of the total members for General Body Meeting and ¼ for Executive Committee meeting.

#### Funds: 6.

The funds shall be spent only for the attainment of the objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means.

The Society is hereby authorised to borrow funds from any Banks, Institutions or Individuals for the purpose of the objects of the Society. And the society is also authorised to mortgage/pledge the movable and immovable properties of the society for the above and to repay such loans along with interest out of funds of the society.

The Executive body of the society is authorised to depute any office bearer of the society to execute the documents for any borrowings on behalf of the society and the society shall board by such documentation executed by such authorised representative

The investment of funds of the Society shall be made in accordance with the provision of Section 11(5) of the Income Tax Act, 1961.

## **ACCOUNTS & AUDIT:**

The Accounts of the society would be maintained as required under the applicable laws and statues and that an audit of the accounts will be carried out by a Chartered Accountant
